Affidavit of Domicile

The town of Hillside, Code Section 21-5, enacted, provides that it is unlawful for any person over the age of 18 to assist, aid, abet, allow, permit or encourage an ineligible student to register or enroll in the Hillside School District on a knowingly fictitious or use his or her address or residence in the registration or enrollment of an ineligible student. Anyone who violates the ordinance is subject to a fine of \$1000.00 and to the payment of restitution which could include tuition costs, investigation expenses and attorney fees.

(To be completed by Hillside resident who is domiciling a student who is seeking to attend the Hillside Public Schools and his/her parent or guardian is domiciling without lease. If this affidavit is completed by a tenant, it must be accompanied by an Affidavit of Owner of Record.)

5. I am aware that if the above named student's residency has been determined as not being a legal resident in the Township of Hillside, then the Board of Education reserves the right to take legal action that may be needed to recover tuition and related expenses incurred in this matter.
6. **THE BOARD OF EDUCATION REQUIRES THAT PARENTS/GUARDIANS AND HOMEOWNER/LEASEE MUST PROVIDE THREE (3) DOCUMENTS AS PROOF OF RESIDENCY WHEN USING THE AFFIDAVIT OF DOMICILE FOR REGISTRATION. THE ACCEPTABLE SUPPORTING PROOFS OF RESIDENCY ARE LISTED IN THE REGISTRATION PACKET.**
